1. Performance Security in the form and the amount stipulated of the following schedule:
  - a) Cash, Certified Check, Cashier's Check or Manager's Check, Bank Draft or Irrevocable Letter of Credit – Five Percent (5%) of the Total Contract Price; or
  - b) Bank Guarantee – Ten Percent (10%) of the Total Contract Price; or
  - c) Surety Bond callable upon demand issued by GSIS, a surety or insurance company duly accredited by the Insurance Commission or a combination thereof – Thirty Percent (30%) of the Total Contract Price.

The performance security shall be at least co-terminus with the final completion of the contract, and the following provisions shall form part in the Performance Security: ***"The right to institute action on the penal bond pursuant to Act No. 3688 of any individual firm, partnership, corporation and association supplying the contractor with labor and materials for the prosecution of the work is hereby acknowledged and confirmed."***

2. Contractor's All Risk Insurance (CARI) from the GSIS pursuant to Article XII of the provision of the draft contract agreement issued as part of the bid documents. No advance payment and progress payment shall be given if the CARI is not submitted.

Failure to enter into the said contract or provide the Performance Security and Contractor's All Risk Insurance (CARI) shall constitute a sufficient ground for cancellation of this award and forfeiture of your Bid Security.
